Generally, nominees should currently be in a senior leadership role or previously have been in a senior leadership role. Nominees do not need to be currently employed. **The recipient of the 2022 NCHL INTERNATIONAL HEALTHCARE LEADERSHIP AWARD will be honored on Tuesday, November 15, at the 2022 NCHL All-Member Conference in Chicago.**

2. Demonstrates the ability to lead across organizational, professional, cultural, and international boundaries.
3. Shows strong leadership practices by serving as a role model, mentoring others, and creating high-performing teams.
4. Has achieved measurable improvements in organizational performance and value.
5. Is recognized and respected within the field and uses this influence to positively shape the industry.
