

▲ 2023 US-Bahrain/Kuwait International Healthcare Partnership Forum Expression of Potential Intere

The USCIPP team at NCHL is in the process of planning this year's international business development events for USCIPP members. While we had originally planned to host an in-person event in Saudi Ara in 2023, we learned earlier this year that the International Trade Administration (ITA) is hosting its own healthcare-focused trade mission to Saudi Arabia September 9–14.

Given that we anticipate a number of USCIPP member organizations will have already traveled to the region to participate in ITA's Saudi trade mission, we've conferred with the USCIPP Global Market Development Subcommittee and have been in discussions with our in-country partners in Bahrain as

Kuwait about hosting activities in one or both countries the week of September 17 (immediately following the conclusion of ITA's trade mission to Saudi Arabia).

At this time, we are interested in understanding which USCIPP members may be interested in participating in in-person business development events in Bahrain and/or Kuwait organized in close cooperation with ITA, the Department of State, the US Embassy, and other partners in these markets

In terms of programming, we are asking our partners to help organize participation from:

- Leaders from Bahraini/Kuwaiti public- and private-sector clinics, hospitals, and health systems interested in partnerships with US hospitals, with an emphasis on specialty care (such as pediatrics)
- Bahraini/Kuwaiti physicians, particularly cardiologists, oncologists, pediatricians, neurologists, and rehabilitation specialists
- · Bahraini/Kuwaiti insurance companies
- · Bahraini/Kuwaiti Ministry of Health officials (including officials responsible for education and train programs, telemedicine, and clinical partnerships)
- For Kuwait, officials from the Department of Treatment Abroad and the Kuwait Oil Company

We anticipate that the format would involve a mixture of:

- Presentations
- · Roundtable discussions
- · Site visits to hospitals and clinics
- · Receptions and networking
- · Potential matchmaking

Saudi Arabia currently accounts for 60% of the Gulf Cooperation Council (GCC) countries' total healthcare expenditure, Under Vision 2030 plans to:

- Invest over \$65 billion to develop the country's healthcare infrastructure.
- Increase private sector contribution from 45% to 65%, targeting 290 hospitals and 2,300 health centers.

• Launch "health clusters" and expand the usage of digital health.

The trade mission will include one-on-one business appointments with potential buyers, distributor and joint venture partners. In addition, delegates will participate in meetings with relevant government authorities such as the Ministry of Health as well as with business groups like the Chamber of Commerce, who will address several topics like procurement, tenders, policies, and regulations.

Target sectors for U.S companies include:

- Digital Health
- Medical Devices
- Hospital Operation and Management.
- Other firms in the healthcare space will also be considered and should apply.

The participation fee for this trade mission will be \$3,100 for small or medium-sized enterprises (SMI and \$4,100 for large firms or trade associations. The fee for each additional firm representative (large firm or SME/trade organization) is \$1,000 for all three stops. Expenses for travel, lodging, meals, and incidentals will be the responsibility of each mission participant. Interpreter and driver services can larranged for additional cost.


